Research Interests

Previous and current research interests are focused on two specific areas. The first area is polymeric film coating technology and is concentrated on the properties of polymeric films applied to solid surfaces. Previous studies were focused on the effects of the substrate on the structural arrangement of polymer chains within applied films and the relationship between polymer structure and the physical, mechanical, adhesive, and drug release properties. These studies enhanced our understanding of the mechanisms involved in polymeric film formation and polymer adhesion.

The other major current research area involves the transdermal penetration of chemicals through the skin. The development of new transdermal delivery system and enhancing technique for the transdermal delivery of antiemetic drug which will increase patient adherence to the drug and facilitate drug dosing.
